UNESCO was as Head of SHS in the UNESCO-Beijing Office. I also had the pleasure to serve as an Advisor to the Permanent Delegation of Saint Lucia to UNESCO during the 34<sup>th</sup> session of the General Conference.

My interest in serving as a member of AFUS Executive Committee would be to further reinforce links between past and current serving members of our Organisation, highlighting AFUS's work and value-added to as broad an audience as possible.
